NEW BUSINESS

PAC Presentation – Kara Clarke (has been with WPAC since 2016)

- The WCPAC exists because of the law (IDEA and MARSE)
- Made up of parents and guardians of children with disabilities PAC Representatives "shall consist of parents of students with disabilities" (Michigan Administrative Rules for Special Education {MARSE} 2018).

- Min of 1, max of 2 reps per district/charter.
- Detroit, due to size has up to 5 reps.
- Term for each rep is 3 school years, no term limits
- WCPAC members actively participate in the development and/or modification of the Wayne
 County Plan for Delivery of Special Education Programs and Services and provides input on
 matters the committee deems appropriate for the improvement of special education services in
 the county.
- Information source for other parents, staff members and interested individuals in their respective communities. Some also serve as education advocates (not a requirement).
- Meet monthly 2nd Thursday of every month Sept-June at 6:30 p.m.
- Each meeting includes a parent training/presentation related to topics that have been identified by WCPAC Members. Meetings are open to the public.
- Currently meeting via Zoom. When meeting in person, meetings are held at Wayne RESA.
- To become a WCPAC prospective members are nominated by their local school board/district. That nomination is sent to RESA and presented to the WBOE. 3-year term begins on the day of approval by the WBOE.
- We utilize the Remind system to keep our members and members of the community informed about meeting dates and any urgent matters.
- Like the WCPAC, the LPAC exists due to rules in the MARSE.
- LPAC Led by Dr Pat Mies, principal at the Western Wayne Skills Center
- There is parent representation from the schools in LPS and meet bi-monthly. Each meeting consists of a training or education piece related to students with disabilities and that all parents are welcome to attend.
- The next meeting for both these groups is on Thursday, May 12th. LPAC meets at 6p and the WCPAC at 630p.
- The LPAC will be an open forum, so we are able to find out what topics people would like covered next year.
- WCPAC will have an OT from LPS presenting on picky eating. She presented last year, and it was one of our most requested and attended presentations.
- Last meeting of the year in June will have a few different districts and organizations presenting on post-secondary transition.
- May 19, 2022, at 6:30 p.m., WCPAC Special Recognition Ceremony. Celebrate and honor those that have made a positive impact on/for students with disabilities throughout Wayne County.
 Some amazing Livonia educators will be honored.

<u>IEP/504 Binder Organization Workshop Presentation</u> – Andrea Malenfant

- Would request the presence of special education representatives from the district as well as other district members, to explain their role and answer any questions.

- A power point presentation would be shown on how to organize the binder and distribution of the binders.
- Will use a Google Doc to make this an RSVP event.
- Stated that Andrea would seek donations and maybe Council holds a fundraiser at Shake Shack to fund this. Andrea Oquist stated that she would like to take this proposal to her Chamber Colleagues to see if they would fund this. Andrea M. will provide a proper proposal.

National PTA Bylaws Updates – Andrea Malenfant

- NPTA will be voting to amend their bylaws at their National Convention in June.
- One of the Proposed amendments states:
- Article VIII Elections and Appointments Section 2. Officers and Board Members A. Eligibility
 - 1. No member of the nominating and leadership recruitment committee shall be eligible to be slated or self-nominated for election until at least one calendar year has passed following the end of their term on the committee.
- This could prove problematic in the future not only to Council, but to units as well. It may make the creation of nominations committees more difficult.
- Lynda S. recommends sending a letter to MI PTA regarding these concerns as some of them will be present at the NPTA convention and can pass on the concern.
